### RETREAT GROUPS/FACILITY INFORMATION SHEET

Planning a retreat? Wi-Ne-Ma Christian Camp can be the place. Conveniently located on the Oregon Coast with warm lodging, food service, meeting areas, and recreation opportunities, Wi-Ne-Ma Christian Camp allows you great opportunities to conduct an effective group retreat.

Wi-Ne-Ma Christian Camp is located at Milepost 94 on Highway 101 in Tillamook County, Oregon. From October through May the Camp's facilities are available to host groups of 15-200.

#### Building Packages

- 1. Winfield Commons and South End Cabins.** Sleeping, cooking, and meeting facilities for 50-120 people. The meeting room for this option is Lakeside Lodge. Camp can provide the food service. Minimum 50 people.
- 2. Morse Lodge:** A self-contained lodge for up to 26 people. Sleeping, cooking, dining, and meeting room are all in this building. Minimum 15 people.
- 3. Myrtleward Lodge:** Retreat center for up to 60 people. The Camp provides the meals for this facility and the minimum is 30 people. Patience Hall is the meeting room for this Lodge.
- 4. All Buildings:** Includes Morse Lodge, Myrtleward, and Winfield Commons and all of the cabins. Minimum 120 people.

#### Food Service Information

Food service is available through Wi-Ne-Ma Christian Camp for guest groups using the Winfield Commons and South End Cabins package and the Myrtleward package. Camp will purchase, prepare, serve, and cleanup for your retreat. Served cafeteria style the menu is set by our Food Service Manager according to the age of the group. Meals include salad bar, beverage and dessert.

Cost: \$6.75 per person (age 6 and older) per meal (minimum 30 people)

We will contact you at least two weeks prior to your retreat to discuss menu variations or preferences. We also need at least two weeks notice in order to provide food service. We reserve the right to negotiate a different price should you ask for food service beyond our usual offerings. Meal times and number of meals served can be adjusted according to your schedule.

There are limited opportunities to cook for yourself providing your own food service if you are using the Winfield Commons and South End Cabins package. There is an additional fee attached to this.

You are responsible for all food purchase, preparation, service, and clean up before your leave.

The person overseeing your food service needs to have a current "Food Handlers Permit." Please provide a copy of this permit for our files prior to your arrival.

Camp Staff will meet with your cooks upon their arrival to acquaint them with our equipment, policies, and procedures. Your cooks should be prepared to work safely and efficiently in a commercial kitchen.

This does not give you exclusive use of the kitchen. We reserve the right to use the kitchen as we prepare for other groups we may be catering. We will contact you prior to your arrival to discuss your use of the kitchen and to set a time to meet with your cooks.

The Kitchen area is used by permission only. It is off limits to those who are not employees of the Camp or part of your food service staff. Be aware of the safety issues present in a commercial kitchen.

The restroom in the Kitchen is for food service staff only.

Be aware of your responsibility to maintain the kitchen as a safe and clean environment.

### **Program Information**

The Camp does not provide overhead projectors, slide, movie, or other media projectors, screens, VCR, televisions, or sound system. The major meeting rooms, however, have a blank wall often used to project images.

We cannot be responsible for any equipment, instruments, or other items you might bring. You leave them in the buildings at your own risk.

The meeting rooms assigned to you will not be used by another group so you can set the room up as you like.

### **Recreation Information**

Volleyball and basketball both in and out of doors. Bring your own balls and mark them well.

Guest groups using the facility must share the gym. You need to arrange the use of it between yourselves.

There must be adult supervision in the gym whenever your group is using it. Please do not play games which require kicking balls in the gym. Please stay off the stage.

We have beach frontage which must be used with caution. Monitor the tides and be cautious using the beach.

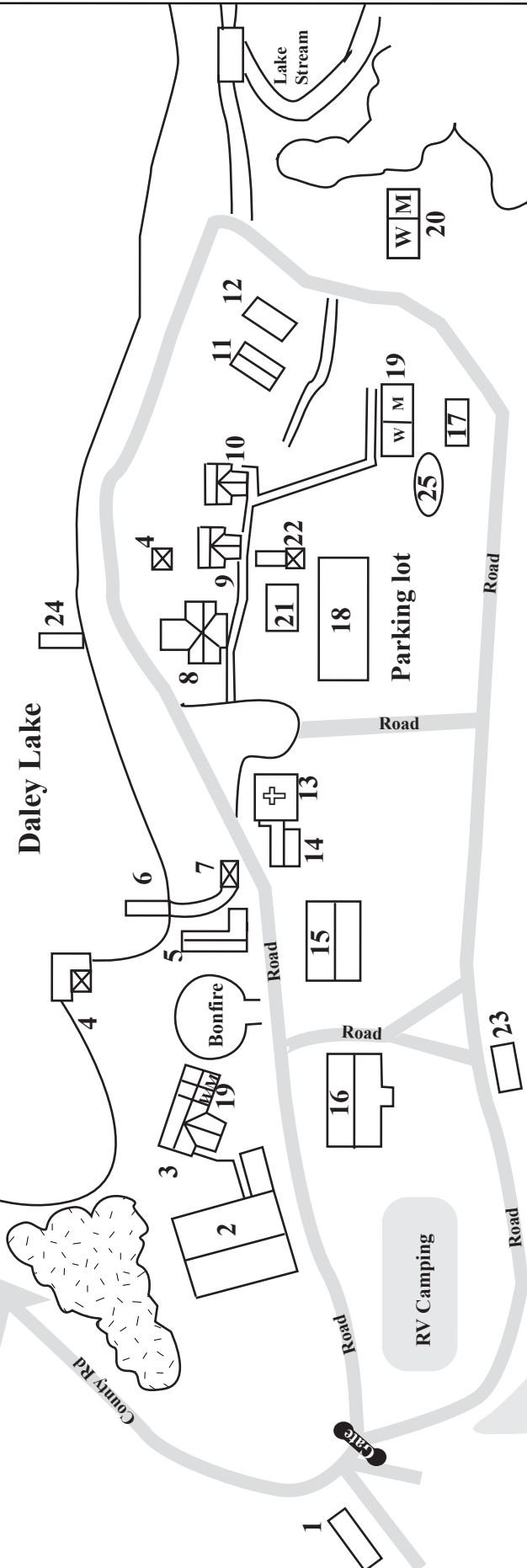
Skate boards, roller skates, roller blades, and bicycles are not allowed.

There are funyaks and a water slide at the lake front. If you wish to use the waterfront area you must schedule at least a week in advance; but it can be cancelled due to weather any time. The waterfront is closed between October 15 and April 15. The fee is an additional fee to use the waterfront.

There is a miniature golf available depending on weather conditions all year long. Please use putters in an appropriate manner and make an effort to return all putters and golf balls.
