General Info

Food Service: The menu is set by our Food Service Director according to the age of the group. We can accommodate most dietary restrictions. We need at least **two weeks' notice to meet your group's dietary restrictions, and a final count the week prior to your event.** We reserve the right to negotiate a different price should you ask for food service different from our normal practice.

Health & Safety: You will need to bring an adult health service person with you to serve as your designated safety person. This person must hold a valid, in-date CPR certification. We also strongly recommend that you bring an emergency First Aid Kit and weather radio capable of receiving NOAA public alerts.

The following items must be provided no later than 2 weeks before your arrival.

- **Certificate of Insurance** naming Wi-Ne-Ma Christian Camp as an additional insurer for your event. Please send the information by email to: winema@winema.org
- **Copy of Certification for your designated Safety Person (valid, in-date CPR certification).**
- **Copy of Current Food Handlers Certification.** Required only if you are doing your own food service (Morse Lodge or Dining Hall rentals).

Guest Groups Policies

You are responsible for communicating the following expectations to your group. Failure to comply with these policies may result in termination of services and/or inability to book with Wi-Ne-Ma again in the future.

1. **Youth must be supervised at all times.**
2. **Quiet hours are 10pm-8am.**
3. **No pets are allowed on camp property.** If a member of your group brings an animal, they will be asked to leave. If a member of your group needs to bring a service animal, Wi-Ne-Ma Christian Camp must be notified and the animal's certification must be provided prior to your arrival.
4. **Alcohol, illegal drugs, tobacco, vaping, firearms, and BB, airsoft, and paintball guns are prohibited.**
5. **Skateboards, bicycles, and rollerblades are prohibited.**
6. **Lake use is prohibited without express permission from Wi-Ne-Ma Christian Camp, granted prior to your arrival.**
7. **Use only the designated fire pits and never leave fires unattended.**
8. The sponsoring organization is required to **identify Wi-Ne-Ma Christian Camp, Inc. as the license holder** in promotional & information materials pertaining to this event. E.g.: *Wi-Ne-Ma Christian Camp, Inc. is the license holder for the facilities used for this event.*
